## *Medicine at the Crossroads, Again?*

Thank you all for the honor of allowing me to serve as your president for the next 12 months. I am humbled and challenged by the privilege during this time of great national focus on healthcare and the practice of medicine.

The *practice* of medicine in the United States continues to evolve under influences both internal and external as a part of the larger business of American healthcare. Physicians are painfully aware of the powers outside medicine and even outside healthcare that have profound effects on our ability to pursue our chosen profession. The external assault is as vigorous today as any time in recent memory, and the outcomes may significantly change our lives.

Criticisms of American healthcare target appropriate concerns about the comparatively high cost and disappointing outcomes of American healthcare. However, the dependence of many of our population on the "silver bullet theory" may be the single greatest determiner of the health of our citizens and the cost of healthcare. The "corporatization" of healthcare as an investment opportunity with only nominal physician input is another determinant. Most physicians, as my dear, departed friend, Brad Hale would say, "Are busy doctoring as fast as we can." As we minister to patients and use our best efforts to improve health and relieve suffering in our own individual ways, we may lose track of opportunities or responsibilities to our profession, and thus to our community, that only we can provide.

It is not a surprise that many physicians feel we are in the crosshairs of an assault empowered by forces that lack substantial understanding of the elements of our decision-making or the constraints under which we provide care. Physicians have the potential to be profoundly affected, individually and collectively, by current events. Each of us may feel we are unable to substantially influence the course of events. However, whether we have chosen a primary care or a sub-specialty career path, medical or surgical, urban or rural, we all have a basic core of training and tradition upon which we call with each medical intervention. The foundations on which we depend daily are collectively the *profession* of medicine. The internal thread of continuity in healthcare must be the profession of medicine; physicians assuming their professional responsibilities beyond the care for individual patients. Two characteristics of a profession are:

1) Skills based on theoretical knowledge that can be applied in practice and

2) Professional association through bodies organized by members to "define, promote, oversee, support and regulate the affairs of its members." Our forefathers, in preamble to the first AMA code of Ethics in 1847, provided some guidance which is still timely:

*"It is not enough, however, that the members of the medical profession be zealous, well informed and self-denying, unless the social principle be cultivated by their seeking frequent intercourse with each other, and cultivating, reciprocally, friendly habits of acting in common. By union alone can medical men hope to sustain the dignity and extend the usefulness of their profession. Among the chief means to bring about this desirable end, are frequent social meetings and regularly organized Societies..."*

My participation in the Indianapolis Medical Society is based on that principle. I am enriched though interaction with physicians of varied backgrounds, some of whom I would meet in no other way. Our concerns as physicians are mutual and go beyond those of our individual specialty and practice arrangements. Our individual ability to effect change is vastly multiplied by our collaboration as has been repeatedly demonstrated in legislative affairs in our state.

At this critical time in the evolution of healthcare and the practice of medicine in the United States, we, the profession of medicine with our unique perspective on healthcare, must fulfill our obligation as the internal force for responsible change in this debate. Your Indianapolis Medical Society will listen to you and together we will look for opportunities to professionally effect responsible change. We are very interested in your suggestions on how the Society can better serve you and your colleagues. Communicate with us. Collaborate with your peers. Recruit a new member to join you in this opportunity to participate in your professional society through communication and participation. Your Indianapolis Medical Society is only as strong as you make it. Thanks for your support personally and professionally. It makes all the difference.

**David F. Box, MD**, has joined the Indiana Eye Clinic and will continue his practice, formerly Southside Eye Associates, at 6243 S. East Street.

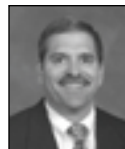

## Be Prepared When Dialing Debtors

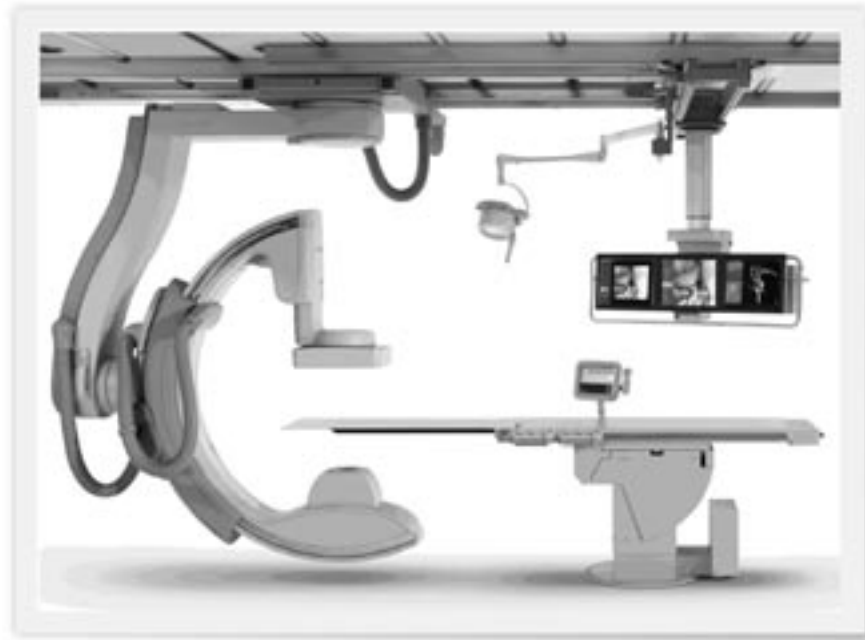

## Project Health

### *Thank you, David C. Hall, MD*



David C. Hall, MD, of Indianapolis Neurosurgical Group is Project Health's doctor volunteer for the month of September. He was born in the North Bay of Ontario, Canada, where his father was a mining engineer for Denison Mines. "We lived in the woods for the first five years of my life until my father

took a teaching job at Michigan Tech University in the Upper Peninsula of Michigan." His mother taught English literature in University settings and earned her Masters Degree at the University of Michigan while they lived there. Then, she taught at Washington State University and subsequently received her law degree in Spokane.

The rest of the family; i.e., his parents, brother and sister, were all born in England. They moved back there after living in the Upper Peninsula a few years. It was in the UP where he discovered he wanted to enter medicine. "They used to have a program to encourage young students to go into medicine by bringing a big van to town which had a medical unit with hearts from people who had died of rheumatic fever, some of whom had valve replacement." So he thought at first about being a cardiovascular surgeon.

"Having lived my young years in the woods and the UP with a population of about 3,000, I was amazed when I first landed in London at how big a city could be. It was great fun when my parents would take me to the railroad station and send me off to London – it was a real treat." He attended the Cateram Boarding School where his father, uncles and grandfather attended. His grandfather was also Headmaster there. Then, it was off to Westcliff School for Boys in Westcliff on the Sea in Leigh-on-Sea in Essex.

From there it was straight to the University of London's Westminster Medical School for a five-year program. "The schools do things a little differently in England," he said. Dr. Hall completed a rotating internship at the Pasqua Hospital in Regina, Saskatchewan, Canada, followed by a surgical internship at the Indiana University Medical Center.

"I had known about Indiana because my brother did a residency in neurosurgery at Methodist Hospital, and I spent some summers here hanging around." He said because his brother and sister were also in boarding schools he rarely saw them until summer. In the summer of 1972, he stayed in Indianapolis and hung out with his brother and John Russell, MD, who went into a partnership with Julius Goodman, MD. "Peter was a

junior resident at the time, and it was the greatest eight weeks I'd ever had in my youth." He spent the following summer here at IU as well. After that the Pasqua Hospital switched him to clinical work, and he didn't have time for vacations. He did manage to do elective work in neurosurgery for three weeks in Minnesota and Toronto in 1976 which helped him decide whether to practice in Canada or the United States. "Neurosurgery in England was extremely limited at that time."

Dr. Hall accidentally came to Project Health when one of our patients was in the Methodist Hospital Emergency Room with a brain tumor. But since then, he has seen several other PH patients. "Your patients have legitimate problems, and it makes us feel good that we can make such a difference in their lives. Most of them were working and want desperately to get back to work. Helping them do that is very rewarding. I also feel that society contributes a lot to our education, so I think a lot of doctors feel the need to give back to society."

Dr. Hall likes the fact that Project Health provides medically certified interpreters for Hispanic patients. "I learned French and some Russian in school. While in England we used to take day-trips to France, so French became my second language. We need those interpreters."

Dr. Hall said he would encourage other physicians to volunteer for Project Health. "It's a nice way to be able to volunteer your service without being taken advantage of. The program allows us to set limits which we can't with Medicaid. It allows us to recognize the importance of giving to the community without being overwhelmed – the Project Health case managers make sure of that. It works out great for me."

Dr. Hall has a 25-year-old son just finishing medical school at IU and will start a general surgery internship in Wilmington, N.C. Another son graduated from the Kelly School of Business and is in China where he matches up American businessmen with factories that can produce their products. His youngest son is finishing up at the Kelley School of Business with an emphasis on real estate and is looking for work. Dr. Hall's daughter is in merchandising and fashion.

When he is not working, Dr. Hall likes to travel and bike. He tries once a year to go on a mountain biking trip out west or to Europe. He has been to Italy a few times and ran into Richard Graffis, MD, of Tower Surgical on the east coast of Italy one year. It really is a small world, which is why Project Health and the Indianapolis Medical Society are grateful that Dr. Hall decided to settle in Indianapolis after that whirlwind childhood.
