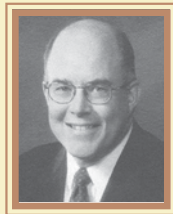


## *Osteopathic Medicine, Part 1*

*Paul Evans, DO, VP and Dean, MU-COM*

*It is my honor to introduce Dr. Paul Evans to the Indianapolis Medical Society. Dr. Evans is the Vice President and founding Dean of the Marian University College of Osteopathic Medicine. He has been active in medical education for decades, having served as founding Dean of the Georgia Campus of the Philadelphia College of Osteopathic Medicine in Suwanee. Dr Evans is also US Army veteran of 26 years, 16 of which were in medical education. Paul has written extensively on primary care, medical education and faculty development.*

I have been asked by President Richard Rhodes to submit a brief introduction on osteopathic medicine for *Bulletin* readers. As the first osteopathic college in Indiana starts up, there have been many questions about what is a DO, what are the similarities and differences in philosophy and training for osteopathic (DO) medicine vs. allopathic (MD) medicine, and what are the plans for the new Marian University College of Osteopathic Medicine.



In this two part series I will answer these questions. Much of this piece is excerpted from the AACOM website, a very useful reference for osteopathic education. (aacom.org)

### **Part 1. Introduction to Osteopathic Medicine**

#### **A. Overview**

Osteopathic medicine is a distinctive form of medical care founded on the philosophy that all body systems are interrelated and dependent upon one another for good health.

Osteopathic physicians use all of the tools available through modern medicine including prescription medicine and surgery. They also incorporate osteopathic manipulative medicine (OMM) into their regimen of patient care when appropriate. OMM is a set of manual medicine techniques that may be used to diagnose illness and injury, relieve pain, restore range of motion, and enhance the body's capacity to heal.

Physicians licensed as Doctors of Osteopathic Medicine (DOs), like their allopathic counterparts (MDs), must pass a national or state medical board examination in order to obtain a license to practice medicine. DOs provide comprehensive medical care to patients in all 50 states and the District of Columbia.

Currently, there are more than 50,000 DOs practicing in the United States. Reflecting the osteopathic philosophy of treating the whole person, many DOs serve in the primary care areas of family medicine, general internal medicine, and pediatrics, often establishing their practices in medically underserved areas. But many others are found in a wide range of medical specialties including surgery, anesthesiology, sports medicine, geriatrics, and emergency medicine. Still others serve as health care policy leaders at the local, state, and national levels. In addition, an increasing emphasis on biomedical research at several of the osteopathic colleges has expanded opportunities for DOs interested in pursuing careers in medical research.

#### **B. History**

The osteopathic medical philosophy was developed in 1874 by Dr. Andrew Taylor Still, who pioneered the concept of "wellness" and recognized the importance of treating illness within the context of the whole body.

Andrew Taylor Still was born in Virginia in 1828, the son of a Methodist minister and physician. At an early age, Still decided to follow in his father's footsteps and become a physician. After studying medicine and serving an apprenticeship under his father, Still became a licensed MD in the state of Missouri. Later, in the early 1860s, he

completed additional coursework at the College of Physicians and Surgeons in Kansas City, Missouri. He went on to serve as a surgeon in the Union Army during the Civil War.

After the Civil War and following the death of three of his children from spinal meningitis in 1864, Still concluded that the orthodox medical practices of his day were frequently ineffective, and sometimes harmful. He devoted the next ten years of his life to studying the human body and finding better ways to treat disease.

Still believed that by correcting problems in the body's structure, through the use of manual techniques now known as osteopathic manipulative treatment, the body's ability to function and to heal itself could be greatly improved. He also promoted the idea of preventive medicine and endorsed the philosophy that physicians should focus on treating the whole patient, rather than just the disease.

These beliefs formed the basis of a new medical approach. Based on this philosophy, Dr. Still opened the first school of osteopathic medicine in Kirksville, Missouri in 1892.

#### **C. Principles**

These are the four major principles of osteopathy:

1. The body is a unit. An integrated unit of mind, body, and spirit
2. The body possesses self-regulatory mechanisms, having the inherent capacity to defend, repair, and remodel itself.
3. Structure and function are reciprocally inter-related.
4. Rational therapy is based on consideration of the first three principles.

These principles are not held by osteopathic physicians to be empirical laws; they serve, rather, as the underpinnings of the osteopathic philosophy on health and disease.

#### **D. Vision**

Osteopathic physicians, also known as DOs, practice in all types of environments, including the military, and in all types of specialties, from family medicine to obstetrics, surgery, and aerospace medicine.

DOs are trained to look at the whole person from their first days of medical school. This holistic approach to patient care means that osteopathic medical students learn how to integrate the patient into the health care process as a partner. They are trained to communicate with people from diverse backgrounds, and practice these skills in their classrooms and learning laboratories, frequently with standardized and simulated patients.

The osteopathic medical profession has a proud heritage of producing primary care practitioners. Osteopathic medical tradition preaches that a strong foundation in primary care makes one a better physician, regardless of what specialty they may eventually practice.

Today, when the challenge of ensuring an adequate number of primary care physicians extends to osteopathic medicine, the majority of most osteopathic medical school graduates choose careers in primary care. Osteopathic medicine also has a special focus on providing care in rural and urban underserved areas, allowing DOs to have a greater impact on the U.S. population's health and well-being than their numbers would suggest.

Osteopathic medicine is also rapidly growing! There are now over 34 colleges of osteopathic medicine with more in development. Nearly one in four of all medical students in the United States is attending an osteopathic medical school.

In Part 2 of this article, I will focus on the needs for a new medical school in Indiana and how both national and local factors are influential in the decision to start the Marian University College of Osteopathic Medicine.



## “Membership”

The Supreme Court will soon decide whether the Federal Government can “mandate” that all people carry health insurance coverage. While no one can accurately predict what will come of that discussion, I suspect that many physicians would benefit if everyone had insurance. However, there are also some parallels with this decision and organized medicine membership.

Today, membership in IMS and ISMA is open to all physicians in good standing, yet only a portion of physicians choose to be members. Health insurance is available to all citizens, yet only some choose to purchase it. The reasons are probably similar for each – the costs are real and up-front, and I’m not certain what benefit I will get if I make the investment. While any form of insurance is essentially betting against oneself, memberships in IMS and ISMA have clear and defined benefits.

One argument FOR all people carrying insurance is that we ALL pay for those who do not. ER care must be provided based on Federal EMTALA rules; care after an accident is deemed to be a right – we do not let our fellow citizens die for lack of insurance; yet the price society and employers pay for this cost-shifting is at a breaking point. Once again, there is a parallel in medical society membership. Those who ARE members incur willingly, or perhaps begrudgingly, the cost of such membership, while every physician in the state of Indiana benefits from the programs, services and advocacy of these societies. Just as uninsured patients are often considered to be “free-loading” on the backs of society and employers, the same might be said for non-member physicians.

The multiple and sequential decreases in malpractice costs over the past several years are DIRECTLY attributable to the efforts of organized medicine. Lobbying efforts, testimony by IMS and ISMA physicians involved on behalf of their profession and their patients is what made the difference.

Not every member of a country club wants to be on the Board; most simply want a tee time, a nice place to have dinner or other club amenities. To have those “perks” there are “dues” or “monthly minimums” in place. Many physicians seem willing to pay these fees, as there is a direct relationship to enjoyment and lifestyle; yet the most important determinants of lifestyle and outcomes for physicians are defined by things like onerous malpractice awards, malpractice rates within a state, and the many intrusions into the practice of medicine. While not all issues can be resolved, without the “one voice” of organized medicine, there would be no hope of physician friendly decisions at the legislature.

We would ALL benefit from increased membership in ISMA and IMS. Spreading the costs of all of the services and benefits over a larger membership would lower everyone’s payments; but more importantly, the voice of our membership would be even more powerful. And we do not even need a Supreme Court ruling on this. JOIN TODAY.

## Thank you, Kenneth G. Ney, MD



Kenneth G. Ney, MD, is Project Health's doctor of the month in June. He grew up in Fort Wayne where his father worked for Magnavox. He said his mom was halfway through nursing school when he came along and spoiled her fun. She ended up as the office manager for a dentist.

Dr. Ney graduated from Snider High School in Ft. Wayne, also home to NFL

Football Hall of Famer Rod Woodson. Dr. Ney says he was always more math and science oriented at Snider and had a "phenomenal chemistry teacher, Gene Buzzard." "He was demanding, difficult, taught the class like we were a college class, but he was fair and very personable. He took great interest in students and was really inspiring."

Dr. Ney entered Purdue University with thoughts of majoring in pharmacy, but changed his mind in the third year. "It was heavily clinical, basically first year medical school curriculum which got me more interested in medicine." He said he had no idea what area of medicine to concentrate on until his junior year of medical school when he rotated at IU. He says the residents really mentored them well, led by the late John P. Donohue, MD, Chairman of the Department of Urology, "and the rest is history."

Dr. Ney did his internship at Northwestern Memorial Hospital in Chicago and completed a six year residency there as well. He and wife, Chyrise (also a Purdue graduate), decided to move to Indianapolis afterwards because he says, "we wanted to stay in the Midwest; Indiana is a great state to practice medicine in; and to raise children."

Some of his friends from medical school days at I.U. told him that three of the big groups were looking, so he wrote letters and landed with Associated Urologists which merged with Urology of Indiana in 2005. They have 18 different office

locations, but he has always practiced primarily at St. Vincent Hospital. He loves all types of urology, but says his niche is in prostate cancer. He is on the daVinci Robotic team at St. Vincent Hospital, and he is starting to move into care for advanced prostate cancer.

Dr. Ney and his wife have three children; a 22-year old son who is graduating from Purdue this year in English Literature and wants to be a musician; a 19 year old daughter also at Purdue who is in health sciences studying to be a Physician's Assistant; and a 15 year old daughter at Heritage Christian High School who he says is "the most incredible ballroom dancer." Mom, Chyrise, has a passion for interior design, makes jewelry and just opened a booth in an antique mall in Carmel. In their time off they like to ski in Colorado and Idaho, bicycle and travel. France and England are favorite travel spots.

Dr. Ney has also been actively involved in a missionary organization in the Ukraine since 1997 that he helped launch. He went to the town of Zhitomir (population 300,000) on his first trip to Russia in 1994 and met three Ukrainian ladies who wanted to start a crisis pregnancy center. So, he and a dentist friend started a medical clinic that now employs 21 people. He works with kids with disabilities. His family has traveled there and he is on the board, along with several other Indianapolis physicians.

"It's part of my DNA as a Christian to help the less fortunate, so when Project Health started we immediately agreed to help. Having been at St. Vincent, I agree with everything they do and their mission. We see it as a calling to help people. It's our oath. It's not a big sacrifice out of my day, and I don't have any idea who is insured or not. The focus is on patient care."
