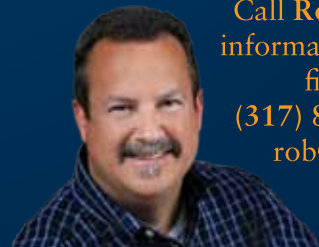

## *Project Health: the Heart of the Indianapolis Medical Society*

As the federal government continues to roll out implementation of the Affordable Care Act, one thing remains clear: There are hundreds of thousands of Hoosiers who don't have access to insurance or quality healthcare. And even with full implementation of Obamacare, that will not change.

Later this year, millions of uninsured Americans will begin signing up for an expanded Medicaid program under the ACA. Yet here in Indiana, the future of the law remains unclear. So far Indiana has yet to expand Medicaid. The Healthy Indiana Plan (HIP) will only cover citizens up to 100% of the Federal Poverty Level (FPL) and already has a waiting list of 55,000 people. Wishard Advantage serves people up to 200% of the FPL and Anthem is the designated "exchange" for everyone else. Even with those choices it is estimated that 145,000 people in Marion County will remain uninsured.

As physicians we have a unique opportunity to help our fellow Hoosiers gain access to quality healthcare. That's why I'm so passionate about my involvement with the Indianapolis Medical Society and more specifically, Project Health.

Project Health is an initiative of the Indianapolis Medical Society Foundation -- helping to expand access to healthcare for low-income, adult, uninsured residents of Indianapolis (Marion County). The project is part of a joint initiative with volunteer physicians, hospitals, community clinics, the pharmaceutical industry and other providers in a system of coordinated, case-managed, charity care.

Since the first Project Health patient was enrolled in May of 2004, the program has grown to include more than 2,000 volunteer doctors, 2,300 patients and the three largest Indianapolis hospital systems. Project Health accepts patients whose incomes are between 201-300% of the FPL -- patients who literally fall through the cracks in the system.

Most Project Health patients are what we call "the working poor." They are without coverage for a variety of reasons. Many held the same job for decades only to lose coverage because of layoffs or a company closure. They take any job they can get, often part time jobs; however those jobs don't come with benefits. A majority of them have always had insurance and have never asked for help before. When they lose coverage they do not know where to turn.

In total, hospitals and doctors have donated over \$38-million dollars in care over the past decade. This care involved 14 open heart surgeries, 3 brain surgeries, 5 corneal transplants, 90 cancer surgeries followed by chemotherapy and radiation, 141 cataract removals, 94 gallbladder removals, 57 shoulder repairs, 40 hand surgeries, 4 knee and 3 hip replacements and much, much more. There have been 40,553 patient appointments resulting in 32,179 procedures.

James McConkey is a self-employed mechanic who required emergency brain surgery after an MRI revealed not one, but two egg-sized tumors in the frontal lobe of his brain. The diagnosis would

have been fatal had there been a delay in treatment. Project Health staff got him an appointment with a neurosurgeon that very afternoon and he was in surgery the next day. "Everyone treated me like I was the most important person on earth," James said. "I can't tell you what it means to a person when you are uninsured, have a life-threatening emergency and don't know where to turn. A millionaire wouldn't have been treated any better or faster."

Then there's Chris and Tom Schrader, Project Health's first "patient couple." Chris survived breast cancer after receiving radiation and chemotherapy treatment through Project Health. Later her husband Tom survived a heart attack and an emergency aortic valve replacement. Chris says, "It still seems like such a miracle that you helped me. And then helping Tom as well? It is just beyond wonderful. We could have lost it all, our lives, our home, and everything we have worked so hard to build. Your helping us has been such a blessing."

Project Health isn't just about life-saving treatment, but preventative care as well. A majority of charity care patients don't visit a physician or clinic at the first sign of illness, because they can't afford the regular preventative care they need. These patients wait until their conditions become serious and intolerable before seeking care. Diabetes patients have come to Project Health with complications of retinal bleeding, uncontrolled blood sugars, heart damage, vascular compromise, high cholesterol and major stroke risk. Almost ALL of their health problems could have been prevented with early detection.

Not everyone without insurance can become a Project Health patient. Not only must they meet the income eligibility guidelines, they must agree to abide by a strict set of rules. Project Health patients have proven themselves to be compliant patients because they know that if they break the rules, they will be dropped from the program. The standards for participation in Project Health are high and the patients rise to meet them.

### **Patient Responsibilities**

In order to ensure eligibility all Project Health patients must:

- Find a family physician or clinic to provide most of their care. If they don't have one, we work with partner physicians to find them one.
- Arrive at their appointments on time, and call the doctor and Project Health if an emergency keeps them from making the appointment. Project Health provides bus passes AND interpreters. We have very few no-shows.
- Make all reasonable attempts to avoid using the emergency rooms for non-urgent care. Frivolous ED visits have dropped from an initial 77% to less than 1% for the last nine years.

## Thank you, Hill Hasting, II, MD



Project Health's Doctor of the Month for October is Hill Hasting, II, MD of the Indiana Hand to Shoulder Center. Dr. Hastings specializes in arthroscopy, reconstruction, and replacement surgery of the elbow, wrist and hand in addition to fracture management, treatment of paralytic upper extremity disorders and shoulder arthroscopy.

Dr. Hastings is originally from Los Angeles. Physicians in his family go back to the 1600's. "My grandfather was an ENT surgeon who cared for Howard Hughes. My father was a general surgeon and mother was an internist/pediatrician." He has two sisters and one brother "all of whom are incredibly close to me." He attended high school at the Thatcher School which bordered a wilderness area. It required students to maintain and care for a horse for the first two years. He was chairman of the school, captain of the tennis team and gymkhana, an equestrian athletic event which exercises the unique athletic prowess of both the horse and rider. In high school he worked as a scrub technician in the operating room which he says piqued his interest in medicine.

He went to college at Williams College in Massachusetts where he competed in soccer, tennis and was on the swim team as a springboard diver. In his senior year he left the swim team to spend more time working for the National Ski Patrol, "putting in as much time as possible cross-country skiing because I felt this would be my last opportunity, which did not exactly prove to be the case." Participating in outdoor sports is a huge part of his life, but he says medicine was his destiny. "I had incredible mentors with my dedicated, caring physician parents."

Dr. Hastings returned home to attend the Keck School of Medicine at USC. He spent two summers doing cardiovascular research at the Harvard Peter Brent Brigham Hospital. From there it was a residency and internship in surgery, as well as a Fellowship in Clinical Research in Hand Surgery at the University of Colorado Medical Center in Denver. He had a six month hiatus before he had to return to Boston, so he moved to Vail, Colorado to practice family medicine in the Vail Valley Emergency Room, "living with my then girlfriend and now wife, Bettie, and competitively ski racing with her every Tuesday. The real lure of Colorado, on top of their incredibly stellar program, was my ability to kayak, rock climb, ski, and mountain climb. This passion never left me, centering me and my family in Telluride, Colorado today." Betty was a hotel and conference manager for the Marriott Mark, which had hosted an American Society for Surgery of the Hand summer meeting where he met Richard Smith, MD, one of the premier educators in hand and upper extremity surgery. Dr. Smith lured him back to Boston for training in orthopaedics at Massachusetts General Hospital and Peter Brent Brigham Hospitals. Dr. Smith urged him to seek a position at what was then the St. Vincent Hospital Indiana Hand Center and the rest is history.

Dr. Hastings is co-inventor of the Biomet Discovery Elbow Replacement System. He also designed and invented, in collaboration with the AO Hand Study Group, the AO Wrist Fusion Plate considered the gold-standard for wrist fusion. He

also helped develop the AO Distal Radius Plating System, the AO Modular Hand Set and the Phalangeal Percutaneous Screw Fixation System. He received the AO/ASIF Innovation Prize for these efforts. He consulted on the Combi Distal Radius Plating System and is collaborating on additional clavicle and upper extremity fracture systems. He designed the Hemi-Hamate Resurfacing Arthroplasty and was awarded the Sumner L. Koch Award by the Chicago Society for Surgery of the Hand as well as the Emanuel B. Kaplan Award by the New York Society for Surgery of the Hand for his investigations on the vascularity of the distal radius and vascularized techniques for bone grafting to the carpus. His research in complex elbow contractures led to his co-development of the Lateral Collateral Preserving Approach to the Elbow for Release of Complex Contractures and a New Classification System for Primary Osteoarthritis of the Elbow.

Dr. Hasting is a member of the American Academy of Orthopaedic Surgeons, past-member of the American Orthopaedic Association, American Society for the Surgery of the Hand, American Shoulder and Elbow Surgeons, American Society for Reconstructive Microsurgery, the International College of Surgeons to name a few. He has been awarded honorary memberships to the Canadian Hand Society, the Venezuelan Hand Society and the Hellenic Society for Surgery of the Hand. Dr. Hastings is also a Medical Consultant for the USA Gymnastics National Team and a consultant and developer for Biomet of its Intellifit fracture repair solutions for the clavicle, elbow and wrist. He has given over 500 national and international presentations and trainings of other physicians.

In his spare time he likes to be outdoors hiking and mountain climbing, horseback riding, skiing, biking, scuba diving, kayaking, and standup paddle boarding, photography and international travel. He and Betty have a horse farm and three Portuguese Water dogs in Zionsville. They also have two daughters, one in her 4<sup>th</sup> year doctoral program in Grief and Trauma Counseling at George Washington University and the other is a General Surgery Intern at LSU.

Dr. Hastings says travel has always been an important part of his life. "It awakens you. It opens your eyes to new and different ways of thinking. It exposes you to other cultures, and in doing so, reinforces your own values and assessment of what is important. Furthermore, medicine overseas exposes you to types of problems that we less commonly now see in the United States. For example, in New Delhi there are approximately 1,000 wrist fractures a day." He has operated in Venezuela, Argentina, India, the UK, France, Germany, Switzerland, Nepal, and Bhutan. "It has been said by many that the more you give, the more you receive. This includes any aspect of your life, not just medicine. We are privileged to have unique skills with which we are able to make a difference. I believe volunteer work and overseas work brings you to unique cultures and individuals. It opens up doors to their lives, their homes, their families and dreams." Project Health can't thank you enough, Dr. Hastings, for making so many of our patients' dreams come true – restoring them to normal function and lives without pain.

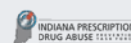

# In Memoriam



**Daniel L. Boyd, MD**  
1930 - 2013

Daniel L. Boyd, MD, 82, passed away Thursday, July 25, 2013, of a rare genetic blood vessel disorder, Rendu-Osler-Weber disease.

Dr. Boyd was a graduate of South Bend Central High School. From there he obtained a scholarship to Indiana University in South Bend. He earned a B.S. degree from the University of Wisconsin, Madison in 1954. His post graduate studies led him to the University of Notre Dame and he earned his doctoral degree from the University of Indiana Medical School in 1961. Dr. Boyd completed his internship 1961-1962, his Internal Medicine Residency (1962-1965) and a Cardiology Fellowship at the IU Medical Center (1965-68).

Dr. Boyd is a Korean Conflict war veteran.

Dr. Boyd taught and conducted research at Roudebush Veteran's Medical Center and taught at St. Vincent Hospital. He was a member of the American Society for Clinical Research and the American Medical Association.



**Morris Green, MD**  
1922 - 2013

Dr. Morris Green, MD, of North Potomac, Maryland, passed away Tuesday, August 6, 2013 at the age of 91.

Dr. Green was a nationally renowned pediatrician, inspiring educator, and prolific author. He dedicated himself to a lifelong commitment to the health and well-being of Indiana's children

through his extraordinary service of almost 50 years to Riley Hospital for Children, serving as its Physician-in-Chief from 1967-1988 and Chairman of the Indiana University School of Medicine Department of Pediatrics.

Dr. Green earned his pre-medical and medical degrees from Indiana University and the IU School of Medicine. He completed his internship at the IU Medical Center and his residency at the University of Illinois Research & Educational Hospitals from 1947-1949.

Dr. Green received numerous awards during his career from many organizations including the prestigious Abraham Jacobi award from the American Academy of Pediatrics. He was also named interim health commissioner by Governor Evan Bayh in 1990. His work in public service, academics, honor societies, organizations are legendary.

Dr. Green was a Captain in the Medical Corps, US Army from October 1945 until September 1947.



**Robert "Bob" E. Cleary, MD**  
1937 - 2013

Dr. Robert "Bob" E. Cleary, 76, of Indianapolis died on August 29, 2013 at his residence after an acute battle with Leukemia.

Dr. Cleary was born on July 17, 1937 in Evanston, Illinois. He received his pre-medical degree at Marquette University and his medical degree from the University of Illinois. He served his residency at St. Francis Hospital in Evanston, Illinois where he practiced medicine specializing in gynecology and infertility. Dr. Cleary was the Assistant Resident in Obstetrics and Gynecology, St. Francis Hospital, 1963-1965; Chief and Senior Resident in Obstetric and Gynecology, St. Francis Hospital 1965-1966; Post-doctoral NIH Fellow in Reproductive Endocrinology, OB/GYNN Department, University of Washington 1966-1968.

He was a Major in the Air Force Reserve.

Dr. Cleary served as section head of reproductive endocrinology and infertility at Univ. of Chicago, IU Medical Center clinical professor ob-gyn, Professor Emeritus 2004, Recipient Memorial Award Pacific Coast Ob-Gyn Society, Fellow ACOG, American Society Reproductive Medicine Society, Society of Reproductive Endocrinologists, Society of Reproductive Surgeons, NY Academy of Sciences. He contributed numerous articles to professional journals throughout his medical career.

Dr. Cleary owned and practiced at Fertility Inc. in Indianapolis, retiring in September of 2003.

# IMS Otis R. Bowen Community Service Award Winner



The Indianapolis Medical Society is pleased to announce that this year's Otis R. Bowen Award for Community Service is **Marguerite Shepard, MD.**

The Otis R. Bowen Award recognizes a physician member of the IMS whose dedication to the community reflects that of Otis R. Bowen, MD, who served as governor of Indiana from 1973 to

1981 and as Secretary of Health and Human Services from 1985 to 1989.

In being nominated for this award, Marguerite Shepard, MD, an OBGYN from Indianapolis and an emeritus faculty member for the last 11 years at the Indiana University School of Medicine, has reached out to her community in ways reflective of the work of Dr. Bowen. She was a fulltime tenured faculty member from 1982-2002 and is still working at the medical center in the Ob-Gyn department. Over the years, her dedication to patients is fabulous, and she has used her knowledge of medicine and women's health to improve the health of Indiana women. She sought out opportunities to work with organizations very early in her career when the protection of reproductive choice was not always a popular thing. She recognized early, that the health of Hoosier women was intimately tied to their reproductive choices, or lack thereof and willingly worked to improve the options available.

Understanding the importance of choice and the need for all women to have the opportunity to conceive, she founded the In Vitro Fertilization Center of the Indiana University Medical Center and served as its medical director for more than 10 years. Her dedication has resulted in the creation of families in and around the state and her techniques are currently in use around the country.

Recognizing that a women's health expands beyond reproduction, Dr. Shepard joined the Indiana State Department of Women's Health Task Force and served as the

Chair of the Osteoporosis/Menopause Committee. Drafting materials to educate women and providers about prevention and treatment of osteoporosis and the management of menopause, Dr. Shepard helped to put the concerns of older women in the limelight and her programs have continued. Empowering youth to achieve their dreams by providing goal-setting programs that promote literacy, fitness and mentoring became Dr. Shepard's next goal as she readily became an active member on the Catch the Stars Foundation board. The Catch the Stars Foundation empowers youth to achieve their dreams by providing goal setting programs that promote fitness, literacy and youth development. The programs are targeted to youth throughout Indianapolis, with a specific emphasis on supporting and assisting underserved and low to moderate income communities throughout the city. Dr. Shepard understands this need and has been an avid volunteer supporter both in time, mentoring, and monetary support

The Indianapolis Medical Society and the IU School of Medicine Women Faculty are proud of her service both within the IMS and academia and outside the university, but also recognize that Dr. Shepard has continued to support all physicians. Though "retired" she is an active participant in many programs and goes out of her way to mentor faculty. She gives easily of her time and talents and many of the successes of her colleagues, both personally and professionally, as well as her community, can be directly traced back to her interventions. Dr. Shepard, like Dr. Bowen, is a physician that recognizes that health care is more than what occurs in an exam room. Health is determined by the state of our community, the policies of our state, the opportunities that are available, and the knowledge and accessibility of providers to care for us.

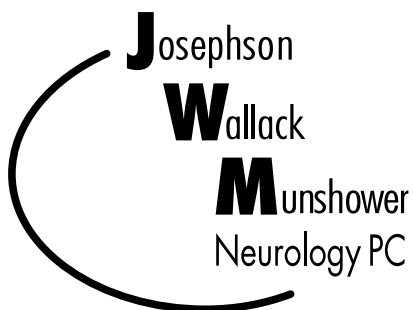

- Follow their treatment plan, get the tests the doctor orders, and get their medication so they can get better and see the doctors less.
- Make sure to have the doctor's office pre-certify any labs, tests or procedures outside his/her office. If they do not do this, the patient will be responsible for the bill.
- Apply for Medicaid or another assistance program at Project Health's request.
- Notify Project Health if they move or change phone numbers.

As a Project Health provider, **you** will decide how many additional charity care patients you can accommodate. All you have to do is treat the patient. Project Health handles all case management. 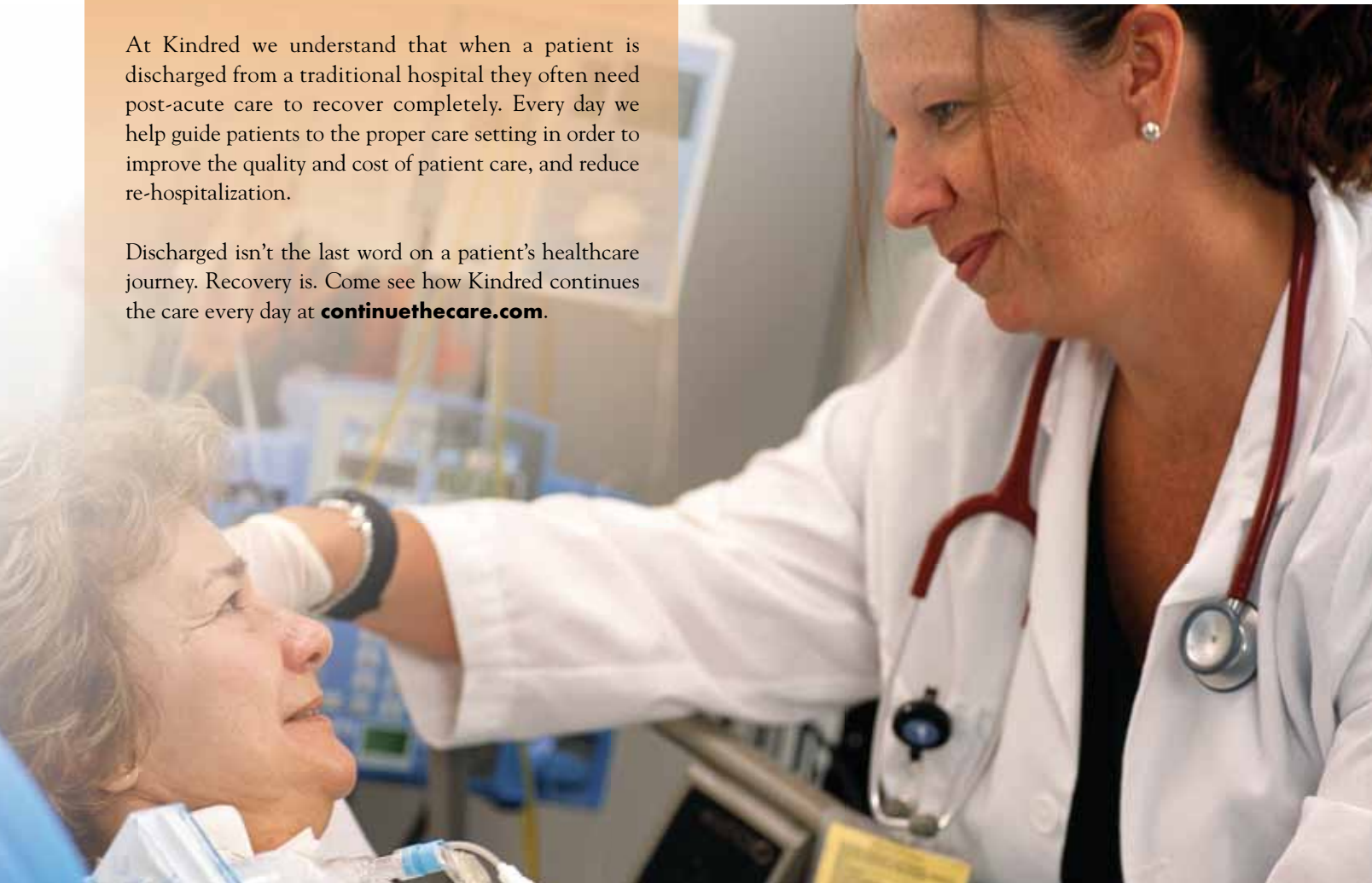

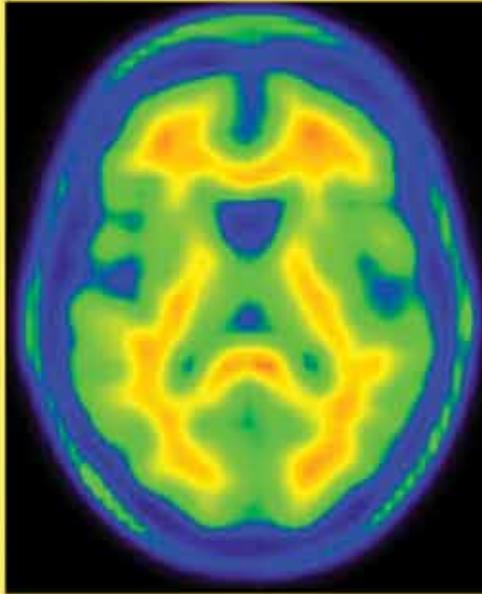

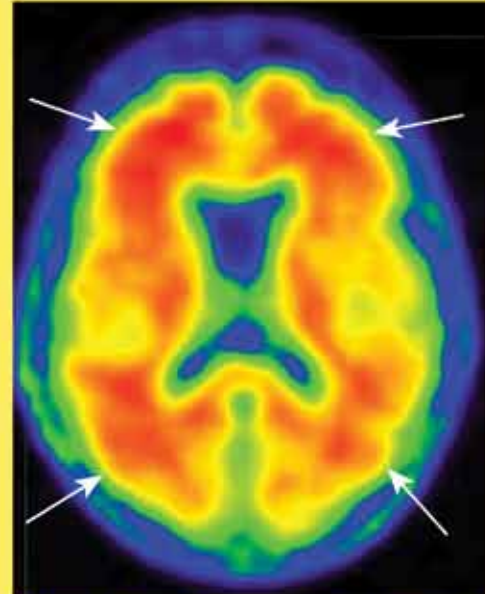
